"Homer was our first, myself and Jennifer, our first Salvation Army appointment as a married couple back in 1991," he said. "We were the first Salvation Army officers in Homer."

Replacing the Bates in Wrangell is Lt.

Jonathan Tollerud. Tollerud and the Bates family actually have a long history. The After a nearly 29-year career, Salvation families have known each other for close army Majors Michael and Jennifer Bates to 30 years, Michael said, and he has known Tollerud since he was a child. It was a surprise to hear that he would be coming to Wrangell, he said, but he hopes the position will be good for him.

Tollerud arrived in Wrangell last Thursday and delivered his first sermon in Wrangell last Sunday.

"I'm very excited to be here, to see what opportunities just arise, ways we can impact the community and help," Tollerud said. "We believe that the Salvation Army is here to be a force for good, hence our slogan 'Doing the Most Good,' but we want to do everything we can to be an impact in the community in big ways."

Tollerud is the son of Salvation Army officers, he said, and grew up moving from place to place. He joined the army at 18-years-old and assisted with the Salvation Army's work in Cordova. In 2017 he moved to California where he attended seminary, or the College for Officer Training as the Salvation Army calls it. He re-

ceived his first assignment in June of this year, to be an assistant in Kenai. Then, when the Bates put in for retirement, he was assigned to be the corps officer of Wrangell.

"Growing up I kind of decided that the place I retire in my life was Astoria, Oregon," he said. "I had never been to Alaska

at that point but I still had decided on Astoria. Wrangell shares a lot of similarities to that area: More of a rainforest, more of a tight-knit community, but it also just rains a lot and I like that. I'm a big fan of

The duties of a Salvation Army corps officer are varied, Tollerud said. Besides seeing to the spiritual well being of the corps and wider Wrangell community, Tollerud will also be helping to organize several social service programs they offer. This includes the food pantry, Thanksgiving and Christmas assistance programs, and utility/rent assistance programs when the funds are available.

Tollerud said that no big changes are planned in the near future, with the change in leadership. In general he said the best idea is to wait 90 to 180 days in a new position before making any wholesale changes to learn what works and what needs improvement. The Way We Were

In the Sentinel 100, 75, 50 and 25 years ago.

November 20, 1919

A special mail route between Ketchikan, Wrangell, Petersburg and Doyhoff has been established in accordance with announcement made by the Postoffice department three months ago, and published in the Sentinel. The new route was established to give additional mail service to Wrangell and Petersburg during the winter months (November 1 to March 31). The power boat that has been placed on the run left Ketchikan on its first trip last Thursday morning reached here Thursday evening.

November 17, 1944

The following announcement from Mrs. Mildred R. Hermann, Alaska director of OPA, has been received by the Wrangell War Price and Rationing board: "Effective Tuesday, November 7, all beef cuts sold at retail in all the larger Alaskan communities are placed under specific prices replacing former ceilings established by individual markets on the basis of the mark-up during the month preceding Pearl Harbor. This is the first price schedule to be set on fresh meats, though specific prices have already been set for over 2000 food and household supply items sold in grocery stores."

November 20, 1969


A special Chamber of Commerce board meeting was held Friday night in the continuing effort to get a resident doctor for Wrangell. Discussions centered on incentives which Wrangell could provide for a doctor interested in coming here. The board compiled a folio of pictures and information about Wrangell and sent it

to a Dr. John Abbott in Longbeach, Wash. Dr. Abbott has been in practice for six or seven years and wrote that he would like to move to Alaska. The board is awaiting his reply.

November 17, 1994

Kray Van Kirk, will be performing in Wrangell Sunday evening at 7 at the Presbyterian Church. His concerts are a weave of traditional Celtic Music, sailing songs, and sea chanteys, a few covers and some early blues, as well as his originals.

"I grew up listening to Pete Seeger, Gordon Lighfoot and the Chieftains," he notes, "so I'm very much in the folk tradition." He is especially fond of the twelve-string guitar, which he describes as a cross between a penny whistle and a bull. Van Kirk tours year round dividing his time between club shows and more formal concerts.

Policies on volunteers, sex offenders, and tobacco use covered in school committee meeting

Wrangell Public School's policy committee met last Thursday afternoon to review several proposed policies for the school district. One such policy refers to volunteers helping out around the school. According to Kim Powell, with the school district, the policy would require anyone wishing to volunteer with the school undergo a background check, if that volunteer will be interacting with students. The policy goes on to state that anyone acting as a volunteer in a classroom, media center, extracurricular activity, or other instructional setting will be supervised by school personnel. There was some discussion about the time and cost of getting a background check done, but the policy largely met the approval of the committee.

Another policy the committee examined was restrictions on sex offenders on campus. The policy states that save for a few listed exceptions, any sex offenders were prohibited from being on school district property. All sex offenders without any children enrolled in the Wrangell school system are barred from campus property save for attending open meetings or a public event, outside of school hours. A parent or guardian of a Wrangell student is also prohibited from campus except to attend a public meeting or event outside of the instructional day. The superintendent or school administrator can provide prior approval for a sex offender to be present on campus property for the following cases: To pick up or drop off their child, to attend a parent-teacher conference or other meetings with school staff related to their child, or "under other special circumstances, on a case by case basis, for which the administrator has given written consent." The policy goes on to explain the procedures for approving the presence of a sex offender on school property, what to do in the situation that a student is a sex offender, and bars electronic communication between sex offenders and students.

Tobacco use was also discussed. The committee was considering a policy outlining the school district as a tobacco-free environment. Anyone on school property or at school-school-sponsored activities would be barred from using, distributing, or selling tobacco products. The policy also states that this applies to all kinds of tobacco products, but not to FDA approved products for nicotine replacement ther-

The committee also reviewed proposed policies regarding the recruitment of superintendents, their contracts, and student activity funds. Superintendent Debbe Lancaster pointed out that this was only a committee meeting, and these policies would have to be approved by the school board before they took effect.





Planning and Zoning Commission elects officers, approves permit for warehouse by the Stikine Inn

The Wrangell Planning and Zoning Commission met last Thursday evening, Nov. 14. The first thing they covered was the election of commission officers. This was not originally on the meeting's agenda, but was added at the request of Commissioner Don McConachie. Commissioner Terri Henson was re-appointed to her position as chair of the commission. Mc-Conachie was named vice-chair.

One of the big items of the evening was a public hearing for a conditional use permit for a proposed warehouse by the Stikine Inn. According to the meeting's agenda packet, the proposed warehouse would be located north of the inn with access off of Stikine Avenue. It is meant largely for storage, according to Jake Harris with the Stikine Inn, as the inn will need more room for storage during its expansion project. Harris also added that the warehouse would also contain an apartment. According to the agenda packet, the proposed warehouse will be 2,475 square feet, 45' x 55'. It will stand about 27 feet

There was some disagreement about this proposed ware-Wrangell resident Kimberly Szczatko attended the meeting with a written statement about her concerns. She is worried that a warehouse will hurt the ocean view for herself, people living near the Stikine, and the general downtown Wrangell area. She also stated she did not feel it was right for the Stikine Inn to "monopolize a popular viewing location." She also said she was concerned about how this warehouse could change Wrangell's traditions. Lastly, among her claims, she stated that the property the warehouse is planned to be built on was appraised at \$64,000,

which she feels was very low for a waterfront property.

"Notice of this proposal was sent to me due to my proximity to The Stikine, however these changes will affect everyone in Wrangell, local and visitor," Szczatko read from her statement. "While the tidewater may now belong to The Stikine, our precious views belong to everyone in the community and it should be protected and respected, not destroyed for The Stikine's financial prosperity."

Harris spoke after Szczatko. He put forward that the warehouse would not interfere with the waterfront view as bad as she fears. He also said that he has spoken with other nearby residents who viewed the project favorably, and was sorry he had not had the opportunity to speak with Szczatko yet. He repeated the necessity of the warehouse for the inn's expansion project, and also said that he was not some outside force coming to change the city. He was wanting to make Wrangell better.

"We're here to continually build this community from the inside out," he said. "We're not an outside interest. I live here, I have family here."

There were no questions from the commission. Commissioners McConachie and Henson said that they understand Szczatko's concerns, and they sympathized, but that the warehouse was necessary and would benefit the town. The conditional use permit was approved.

The commission also approved a final plat requested by Dan Smith and Scott Young, to subdivide their property in the Wrangell Island West subdivision in half, and approved a conditional use permit for a small convenience store located in the Shoemaker Bay parking lot. They also continued their ongoing discussion of rezoning the old Institute property.

Wrangell considers three police chief candidates

Wrangell residents had the opportunity last week to meet people who are interested in the position of Wrangell Chief of Police. The job has been open since former chief Doug McCloskey retired this summer. Eric Hurtado, Thomas Radke, and Derek Bos are all from out of state and have experience running a police department.

Eric Hurtado

Eric Hurtado received bachelor's and master's degrees in business administration from the University of Phoenix in 2002 and 2005, respectively. He worked as a lieutenant with the California City Police Department from 1993 to 2010. Hurtado served as the California City Chief of Police since 2011, until he recently retired a weeks according to California City City Manager Anna Linn. Hurtado has also served as police executive for the California City Police Department from 1991 to the present. In his resume to borough officials he describes himself as a "resourceful, accomplished, and dedicated law enforcement executive with over 29 years of extensive experience in municipal policing."

Linn said that the community of California City and its police department have come to

like and trust Hurtado. With the police department, she said that he trains and trusts the people under him, but is not afraid to pull rank when necessary. He leads by example and has been very generous with his time, she said.

"The community was in mourning when he retired," Linn said. "He's a great guy, the community loves him and we wish him the best."

Thomas Radke

Thomas Radke earned a bachelor's degree in political science and criminal justice from the University of Nebraska-Lincoln in 1990, followed by a master's degree in safety public and administration from University of St. Thomas in 1992. He joined the police department in the City of St. Paul, Minnesota in 1994. He was promoted to sergeant in 1999, then later worked as commander of the City of St. Paul Police Department from June 2016 to December 2017. He joined the Kenyon Police Department as a police officer in June 2018, where he currently works. His resume also lists him as the owner of Red Savoy Pizza in Red Wing, Minnesota, which he acquired in 2017.

"I was excited to see your opening for Chief of Police," Radke wrote in a letter to borough officials. "As a Law Enforcement professional with over 25 years of experience, I am confident I have the qualifications required to become a beneficial member of your team."

Doug Henke is the mayor of Kenyon, and described Radke as a man with great experience and great interview skills. He is someone who really fits into a community once people get to know him, he said. Kenyon Police Chief Lee Sjolander said that the community has come to really like Radke, originally referring to him as "that tall guy from St. Paul" when he first moved to their town. He described Radke as a very polite but stoic man he has made good friends with.

"He has been in charge of a good number of officers over a good number of years," Henke said. "I'll tell you this, I think he could beat up a bear with a switch if he wanted to."

He also holds a bachelor's degree in political studies with an emphasis on criminal justice from Dordt College, earned in 2006.
